#### Institutional Characteristics Overview

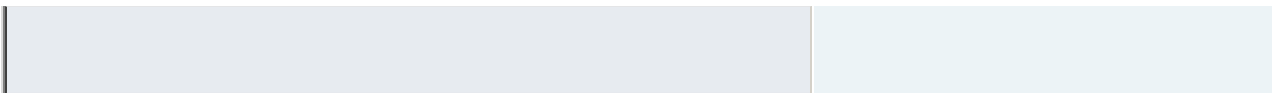
